District Assembly & General Assembly: Darlene will promote DA to our congregation. And finance will set aside the equivalent of 5 "early bird" registrations to help more people within our congregation attend. There are two outstanding keynote speakers and many dynamic workshops planned. Darlene also says she wants to attend GA. Peter is not sure if he will be able to attend. Finance will also look at how much money we can provide to help people attend.

Date for All Fellowship Meeting: We selected Sunday, March 13, 2:00 p.m. Lisa will check the availability of The Home of Truth and then let folks know about the meeting, which will include election of officers.
